GUEST SPEAKER - State Representative Mike Tobash discussed recent legislation. He discussed the recent budget battle impasse. Although the Governor recently signed for the spending amount, he vetoed the fiscal code portion. Rep. Tobash reviewed his efforts to get the budget under control, and efforts to revise the State pension program. As it stands now, the current the defined pension benefit program is growing at an unsustainable cost. He feels that the legislature has to look at solutions such as 401K programs like those in the private sector. He also discussed the prevailing wage issue.
